- We do hereby acknowledge and agree that notwithstanding the generality of the foregoing we declare that we will not commence litigation or otherwise recover damages or other compensation for personal injury or loss of property against any of the parties named herein based on any claim, damages, causes of action or any recourse whatsoever arising out of games, exhibitions, performances, programs and activities organized, operated, or sanctioned by RCSL as a COMPLETE DEFENSE to any and all claims, damages, causes of action, or recourse or liability which may arise at any time.
